

# SOHO Multi-line Offer August Terms and Conditions

## SOHO Multi-line Offer August Terms and Conditions

The following terms and conditions apply to the promotional offer run by Vodafone (the "Offer") which will be available to eligible customers whereby customers may get €20 inc VAT/16.26 ex VAT per month discount from third line up to sixth line new subscriptions if they connect to an eligible 12 or 24 month Bill Pay plan during the Promotion Period.

1. The "Promotion Period" means the period running from 27th August to 23<sup>rd</sup> December 2021.
2. This Offer is open to eligible customers and eligible customers are Customers who, during the Promotion Period and through the eligible channel; (i) add a third up to a sixth additional subscription onto their account, (ii) select a qualifying bill pay plan, subject to the minimum term contract as outlined in appendix A and (iii) have a maximum of 6 subscribers on their account.
3. The Offer can only be added to 3rd - 6th subscription
4. The Offer can only be added at time of sign up – e.g. new subscriptions.
5. Re-contracting and upgrading subscribers are not eligible for the Offer.
6. Existing subscribers on Vodafone are not eligible for the Offer.
7. Eligibility is determined by Vodafone in accordance with these terms and conditions and the group of eligible customers may be varied or amended by Vodafone for any valid commercial, technical or operational reason. Vodafone's determination in respect thereof shall be final.
8. If the subscription(s) is/are removed, then the Offer(s) on the account will be removed. If volume of subscriptions on an account falls below 3, all discounts will be removed. The maximum number of discounts with the Offer are as follows:

15. Where there is any fraud or abuse of the offer of for any reason deemed appropriate, Vodafone may at its sole discretion suspend or immediately terminate the account.
16. We reserve the right at our absolute discretion to vary, delete or add to any of these terms and conditions.
