### Samsung Galaxy Z Flip4 and Samsung Galaxy Z Fold4 Gift with Purchase November 2022 Offer Terms

The following Terms and Conditions ("T&Cs") apply to the Samsung Galaxy Z Flip4 and Z Fold4 gift with purchase ("GWP") Promotion ("the Offer"). The Offer entitles eligible customers to claim one Galaxy Tab S6 Lite (the "Gift") free of charge, by redemption, when they purchase a Samsung Galaxy Z Flip4 or Samsung Galaxy Z Fold4 (each a "Promotion Product") between 1st November 2022 and 30th November 2022 (the "Offer Period").
