Terms for Bill Pay Vodafone Red Business Black Friday 2023 promotional Offer

These terms and conditions apply to the Vodafone Bill Pay Black Friday 2023 promotional offer pursuant to which Eligible Customers can receive up to \leq 350 off selected handsets (as set out at section 3 below, the "Selected Handsets") or alternative discounts off all handsets which are not Selected Handsets (as set out at sections 6 and 7 below) when they sign up to a 24-month RED BUSINESS unlimited bill pay plan during the Offer Period (the "Offer"). The promoter of the Offer is Vodafone Ireland Limited.
