## Terms & Conditions for Vodafone Business Google Pixel 8a Bill Pay Porting Offer

These terms and conditions apply to the promotional offer pursuant to which Eligible Customers may receive the Google Pixel 8A (the "Promotional Product") on us when they switch to a 24-month Vodafone Bill Pay plan (RED Lite, Red Business Lite, RED Unlimited, Red Business Unlimited, RED Unlimited Max and Red Business Unlimited Max) (a "Designated Plan") during the Offer period (the "Offer"). The promoter of the Offer is Vodafone Ireland Limited.
