### Vodafone Business Google Pixel 9 Series Black Friday Offer Terms & Conditions

These terms and conditions apply to the Vodafone Bill Pay Black Friday 2024 promotional offer pursuant to which Eligible Customers can receive €400 off the Google Pixel 9, Google Pixel 9 Pro and Google Pixel 9 Pro XL when they sign up to a 24-month bill pay plan during the Offer Period (the "Offer"). The promoter of the Offer is Vodafone Ireland Limited.

These terms will apply in addition to the terms & conditions under which you enjoy access to your mobile service. These terms form part of your agreement with us. By availing of the Offer, you are deemed to have read and agree to be bound by the following terms and conditions:

1. This Offer is available to "Eligible Customers" only. Eligible Customers are "new to Vodafone bill pay" customers who sign up to a Vodafone 24-month bill pay plan during the Offer Period. This offer excludes 12-month Sim Only plans, 30-day plans, non-unlimited plans, and mobile broadband plans. "New to Vodafone bill pay" customers mean customers who (a) switch their mobile number to Vodafone from another mobile network provider; (b) are first time connections; OR, (c) are prepay to post pay connections. For the avoidance of doubt, it includes New to Vodafone bill pay customers who sign up to a 24-month Vodafone bill pay plan as part of a SoHo Multiline account also. Existing Vodafone bill pay customers and deferred ports cannot avail of the Offer. Eligibility is determined by Vodafone in accordance with these terms and conditions and Vodafone's decision in respect thereof shall be final.
2. The Offer Period is 18th November 2024 to 3rd December 2024 only (the "Offer Period").
3. Eligible Customers who (i) sign up to a 24-month bill pay plan and (ii) select a Google Pixel 9, Google Pixel 9 Pro or Google Pixel 9 Pro XL will receive a €400 discount off the handset.
4. The Offer is available in Vodafone Retail and Franchisee stores, online on Vodafone.ie and via our telesales channel.
5. Eligible Customers can avail of a discount on one handset only in connection with this Offer.
6. This Offer is subject to availability while stocks last and device pricing may vary.
7. Vodafone reserves the right to withdraw or extend the Offer at any time and/or to vary or amend any element of the Offer at any time without further notice.
