Terms for Vodafone Business Mobile Bill Pay Porting Offer

These terms and conditions apply to the promotional offer pursuant to which Eligible Customers may receive a €150 discount off the price of Selected Handsets when they switch to a 24-month Vodafone Business Mobile Bill Pay plan (Red Business Lite, RED Business Unlimited and RED Business Unlimited Max) during the Offer Period (the "Offer"). The promoter of the Offer is Vodafone Ireland Limited.

These terms will apply in addition to the [General Terms and Conditions](#) under which you enjoy access to Vodafone's Mobile Telecommunications Services and any applicable service specific terms. These terms form part of your agreement with us.

The terms are as follows:

1. This Offer is available to "Eligible Customers only". Eligible Customers are customers who; (i) port their mobile number to a Vodafone Business Mobile 24-month Bill Pay plan (Red Business Lite, RED Business Unlimited and RED Business Unlimited Max), from another network provider via any Vodafone sales channel (online, retail store or telesales) or (ii) sign up to a Vodafone Business Bill Pay plan as a first-time connection via a Vodafone retail store, (iii) customers moving from a Vodafone Pay As You Go plan via a Vodafone retail store.
2. The Offer is valid between 05th January and 31st March 2024 (the "Offer Period").
3. Eligibility is determined by Vodafone in accordance with these terms and conditions. Vodafone's decision in respect thereof shall be final.
4. Eligible Customers may avail of this Offer by purchasing a Selected Handset at the time that they switch to the Vodafone network.
5. 'Selected Handsets' means those handsets that are advertised by Vodafone from time to time as being available for a discount to Eligible Customers in connection with this Offer.
6. Eligible Customers who avail of this Offer will be entitled to a discount of €150 (or more, at the sole discretion of Vodafone if so advertised) against the cost of a Selected Handset.

Under the Offer and during the Offer Period, Eligible Customers who sign up to a 24-month Red Business Unlimited or Red Unlimited plans will receive an iPhone 14 128GB or Samsung S23 on Vodafone and Eligible Customers who sign up to a 24-month RED Business Lite or Red Lite plans will receive an iPhone 13 128GB on Vodafone.
8. The Offer is available in Vodafone retail, franchise stores for first time connections, customers who port their number from another network provider and customers moving from a Vodafone Pay As You Go plan to a 24 Month Bill Pay Plan.

10. Handset pricing is subject to change and the Offer is strictly subject to availability
