### Vodafone Business Smartwatch Discount Offer – Black Friday 2024 Terms & Conditions

These terms and conditions apply to the Vodafone Business Bill Pay Black Friday 2024 promotional offer pursuant to which Eligible Customers can receive a €60 discount off smartwatches when they purchase a smartwatch during the Offer Period (the “Offer”). The promoter of the Offer is Vodafone Ireland Limited. These terms will apply in addition to the terms & conditions under which you enjoy access to your mobile service, the [Smartwatch Bundle](#) terms and any additional applicable service specific terms that you have signed up to. 6. Smartwatch Bundle Eligible Customers who purchase a smartwatch through the Smartwatch Bundle will receive this discount as a €2.50 reduction in their monthly price for the duration of their contract.
