

Vodafone 4G & 5G Unlimited Mobile Broadband

The following terms and conditions apply to use of the Vodafone Unlimited Mobile Broadband price plan (“Unlimited Mobile Broadband”) and are in addition to and form part of the General Terms and Conditions of the Vodafone Mobile Telecommunications Service and any additional terms you have signed up to, all of which are available [here](#). We recommend you download and save a copy of these terms for your future reference. If there is any conflict between the terms then the order of precedence shall be as follows: these terms followed by the Vodafone General Mobile Terms and Conditions. By signing up to Unlimited Mobile Broadband you agree to the following terms:

1. Unlimited Mobile Broadband enables Vodafone customers who have signed up to this price plan to use data services via their Vodafone SIM Card using an Unlimited Mobile Broadband modem.
2. The price for 4G Unlimited Mobile Broadband is €30 for the first 6 months of the contract and €40 per month thereafter.
3. The price for 5G Unlimited Mobile Broadband is €40 for the first 6 months of the contract €45 per month thereafter.

5. The Unlimited Mobile Broadband plans allowance comprises unlimited data.
6. Unlimited Mobile Broadband is subject to a 12-month minimum term contract. After this minimum term, we will continue to provide you with Unlimited Mobile Broadband on a rolling basis until either of us decides to end our Agreement in the ways set out in our General Terms (referenced above). You can cancel the Unlimited Mobile Broadband at any time with 30 days’ notice by contacting us; see <https://n.vodafone.ie/support.html>. Please note if you cancel Unlimited Mobile Broadband during the minimum term, you will have to pay an Early Termination Fee.
7. Unlimited Mobile Broadband is subject to availability.
8. Unlimited Mobile Broadband is made available at the discretion of Vodafone and Vodafone reserves the right to vary, amend, alter or withdraw this price plan and/or its terms for commercial, legal and/or regulatory reasons. Eligibility is determined by Vodafone in accordance with these terms and conditions.
