Google Pixel 6 Exclusive Gift With Purchase Offer Terms

The following terms and conditions apply to the Google Pixel 6 gift with purchase offer (the "Offer") pursuant to which customers who purchase the Google Pixel 6 may be offered a Google Nest Hub (2nd Gen). These Offer terms will apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone Business' Mobile Telecommunications Services (found here: <https://n.vodafone.ie/terms/business.html>) and any additional applicable service specific terms that you have signed up to. By accepting the Offer, you agree with the following terms:

1. The Offer is available to Eligible Customers who purchase an Eligible Handset only. Eligible Customers are all new to Vodafone consumer or business customers (ports and first-time connections) and upgrading customers who purchase a new Google Pixel 6 handset ('Eligible Handset') who sign up to any 24-month or 12-month Bill Pay Plan in any Vodafone channel during the Offer Period. Eligibility is determined by Vodafone in accordance with these terms and conditions and Vodafone's decision in respect thereof shall be final.
2. The Offer Period is from 16th May 2022 to 30th June 2022 only.
3. Eligible Handset pricing is subject to change. During the Offer Period, new to Vodafone consumer or business customers (ports and first-time connections) who sign up on any 24-month Bill Pay Plan (RED Business Unlimited Lite, RED Business Unlimited and RED Business Unlimited Max) will not have to pay any upfront cost for the Eligible Handset. Existing customers upgrading during the Offer Period will need to pay an upfront cost of the Eligible Handset.
4. The Offer entitles Eligible Customers to receive one Google Nest Hub (2nd Gen) (the "Gift").
5. This Offer is strictly subject to availability. The customer will receive a unique code via SMS to claim their Gift within 14 working days after the customer has connected to the Vodafone Network. The Gift must be claimed through a dedicated webpage using their unique code. Customers must redeem their Gift within 28 days of receiving their unique code.
6. The Gift is not exchangeable or redeemable for cash or for any other item.
7. This Offer cannot be availed of in conjunction with any other offer or promotion.
8. Customers cannot claim the Gift if they have returned the Eligible Handset to Vodafone for refund or exchange. If the Gift has already been claimed, it must be returned with the Eligible Handset.
