

Xiaomi 12 Promotional Offer Terms and Conditions

These terms and conditions apply to the Xiaomi 12 Gift with Purchase Offer (the "Offer") and enhanced trade-in service (the "Service"). The Offer entitles Eligible Customers to receive one Xiaomi Smart Home and Security Bundle (1x Xiaomi Mi Smart Speaker, 2x Xiaomi Mi 360 1080p Cameras, 1x Xiaomi Mi Smart Clock) free of charge when they purchase the Xiaomi 12 between April 22nd 2022 and May 20th 2022. The Service entitles eligible customers to avail of an enhanced trade in discount of €200 off when they trade in an eligible phone when purchasing a Xiaomi 12 between April 22nd and June 31st, 2022. These Offer terms will apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone Business' Mobile Telecommunications Services (found here: <https://n.vodafone.ie/terms/business.html>). These terms form part of your agreement with us. By accepting the Offer and/or Service, you agree with the following terms:

1. This Offer is open to Eligible Customers only. Eligible Customers are SoHo Business Customers who purchase the Xiaomi 12 in any Vodafone sales channel during the Offer Period.
2. Eligibility is determined by Vodafone in accordance with these terms and conditions.
3. The Offer Period is April 22nd 2022 – 20th May 2022 inclusive.
4. Eligible Customers may receive one Xiaomi Smart Home and Bundle (the "Gift") free of charge.
